PSM Holds Regular Fire Training Drills

bti is one of the first real estate developers to have taken an active initiative in ensuring fire safety and security in all of its buildings. In recent years, our SBU, PSM (Property Security and Management) has single-handedly dealt with providing adequate fire safety equipment at our Head Office, branch office, in all of our completed projects and all of our project sites as well.

We arrange for experts to come and host fire drills on a quarterly basis, where all residents/ tenants must participate to raise awareness as well as learn how to respond in an emergency/ crisis situation. The equipment is also upgraded at regular intervals. We have always believed that it is our social responsibility for proper fire safety measures to be taken at every bti development, as well as our offices.







This year, one of the most remarkable feats that took place were the REHAB elections for 2024-2026. This was the first election held by the Real Estate and Housing Association of Bangladesh (REHAB) in a decade. The vote was held peacefully on 27 February, 2024 amid great fanfare.

Representatives of each of the member organizations were present during the elections to cast their votes and display their support for their favorite candidates. The candidates contested the elections in four separate panels. After all of the votes had been cast and counted thoroughly, the chairman of the REHAB election Board and Joint Secretary of the Ministry of Commerce Subrata Kumar Dey announced the results. The Housing Traders Oikya Parishad led by Wahiduzzaman and Liaquat Ali Bhuiyan won the election for 2024-2026. They won 25 out of 29 directorial posts in Dhaka and Chattogram.
